Dear Harvard Club Members,

Please join us for the Harvard Club of Washington, DC's 2012 Annual Meeting. The meeting will be held on the evening of Wednesday, June 20, 2012 at Anderson House, the beaux arts mansion of former club member Larz Anderson III, Class of 1888, and current home of the Society of the Cincinnati. The primary order of business will be the election of directors and officers.

The Club's Nominating Committee, chaired by Immediate Past President David Treworgy, MBA '93, has proposed the following slate of officers:

The Club has 12 at-large board positions. Each position is a three-year term, and the positions are staggered so that four expire each year. For the four three-year director-at-large positions with terms expiring in June 2015, the Nominating Committee nominates: Yi-Fun Hsueh, AB '87, JD '91; William Gray, ALM '10; Brig Pari, AB '86; and Cora Yamamoto, AB '75. In addition to these positions, there are two director at-large positions with terms expiring in June 2014 that were formerly held by T.K. Yang and Merrie Shippereit, who are proposed for Officer positions. For these positions, the Nominating Committee nominates: Jacqueline Bennett, AB '86 and Ladan Basiripour, DMD '93.

The Nominating Committee observes that these nominations, together with the existing directors, would ensure a sufficient number of recent graduates to meet the requirement of Section 4.02(c) of the Club's bylaws that at least four board members "shall have attended Harvard University...within the past ten (10) years when elected."

In addition, the Club would like to express its appreciation to the officer and at-large Board members who will be stepping down from the Board. We offer our profound thanks to Abby Phillip, AB '10, the current Secretary; Tom Karr, AB '84, one of our Schools Committee Co-Chairs; and Amanda Gregory, JD '94, and Donald Tighe, MPA '99, current at-large Board members. Further, the Club would like to offer a special thanks to David Treworgy, our Immediate Past President, for his wise counsel for these past two years. These outgoing Board members have all contributed countless hours of dedicated service to the Club.

Dear Harvard Club Member,

At its meeting on April 12, 2012, the Board of Directors passed a motion to issue a proposal to amend the Club's by-laws. Pursuant to Section 10.01(b) of the by-laws, the Board is hereby providing you notice of the proposed amendments and offers you an opportunity to provide your views before the Board takes final action.

The District of Columbia recently adopted a new Nonprofit Corporation Act (the "Act"), which took effect on January 1, 2011. The Act is a comprehensive revision of the law that applies to nonprofit organizations in Washington, DC. The proposed amendments to the Club's by-laws first and foremost are intended to make the by-laws consistent with the Act. The Board of Directors took the opportunity to make other revisions to the by-laws that are not required by Act but are advisable to update or eliminate certain outdated provisions and to codify certain existing Club practices.

The proposed amendments include the following:

- Authorize a special meeting of members at the request of at least 25% of the voting members.
- Update the means by which the Club may deliver notices to a member to include email or other electronic delivery if authorized by the member.
- Establish a record date to determine the members entitled to notice of a meeting and to vote at a meeting. The record date is 30 days before the meeting.
- Make clear that the quorum for a meeting of members is 25 voting members.
- Permit the removal of a director for cause by vote of the members, as well as a vote of a majority of directors then in office. Authorize the Board to treat four unexcused absences from Board meetings over a 12-month period as cause for removal of a director.
- Revise the list of powers that the Board may not delegate to a committee.
- Remove outdated references to Radcliffe College in the description of the Schools Committee. Eliminate the requirement that members of the Schools Committee must be members of the Club.
- Make technical corrections to the rules concerning Board meetings, and permit directors to participate in Board meetings by telephone.
- Eliminate the requirement that the Club obtain bonds to secure the performance of certain directors, officers and employees.
- Amend the list of records to be kept at the Club's principal office.
- Revise the rules concerning indemnification of directors and officers to conform to the D.C. Nonprofit Corporation Act. The by-laws require indemnification of directors and officers who meet at least the minimum standards of conduct described in the new statute.

The foregoing is a partial description of the proposed amendments. A complete copy of the proposed amendments is being sent to members with email addresses on file with the Club.
